Sealed tenders are hereby invited for the Digital printing and supplying of Form-6,7,8,8A and other related Forms, from the resourceful and bonafied Agencies / Bidders in connection with the Summary Revision of Photo Electoral Roll 2019, Continuous Updation 2019 and Pre-Revision 2020 for Hooghly District.

Rate should be quoted separately for ¼ size demai white paper not less than 54 GSM single side and for both side printing and for 1/2 th size demai white paper not less than 54 GSM both sides as well as single side printing.

Sealed tender duly filled in and accompanied with other documents (as stated below) should be submitted in the box earmarked for this purpose to be kept in the office Chamber of the Officer-in-Charge, Election Department, Office of the District Magistrate, Hooghly by 1.30 p.m. on 16.08.2018.

The word "Sealed Tender for Printing & Supply of Forms in connection with SRER-2019" should be scribed on the top of cover containing the tender.

The tenders will be opened on 16.08.2018 at 4.00 p.m. in the office chamber of the Officer-in-Charge, Election, Hooghly where the tenderers may remain present.

1. Sealed envelope shall contain the following documents, with the Financial proposal, in absence of which the offer shall not be considered:
 - a) Demand draft of Rs. 25000/- (Rupees twenty five thousand only) as Earnest money in favour of "Additional District Magistrate(Election), Hooghly".
 - b) Photocopy of the Trade License .
 - c) Photo copy of Professional Tax Clearance Certificate.
 - d) Photocopy of Income tax return and PAN Card.
 - e) GST Registration Certificate.
 - f) Working Experience certificate of minimum 3 years or more in any District of India as per guidelines of Election Commission of India.
 - g) Certificate of annual turnover for last two years. Not less than Rupees Fifty Lakh (Rs. 50,00,000/-) per year during the last two assessment years, will be accepted.
