3. Incomplete and illegible quotation not be entertained.
4. Item shall be supplied in good condition and as per specification mentioned in supply order .
5. The quotationer will be fully liable in case of any damage and he shall be bound to replace the damaged item free of cost within the period of warranty/guarantee.
6. The rate of as shown by the quotationer shall be final and no escalation price will be allowed.
7. Supply of the item shall have to be completed within 07(Seven) days from the date of the supply order.
8. During the warranty period all complaints shall be attended within 24 hours.
9. The quotationer shall have to supply the items to the office of the undersigned at free of cost and payment will be processed after verification of the items by the office .
10. The quotationer shall warranty that the item is new , free from all manufactural defects and faulty materials.
11. The quotationer shall conform the item to the highest grade ,consistent with established standards and shall perform in full conformity with the specification. if it becomes necessary to replace any defective portion of the item under this clause ,the provision of the clause shall apply to the portion of the item so replaced until the expiry of aforesaid period .if any defects will not be remedied within a reasonable time the undersigned may proceed to the works at quotationers risk and expenses without prejudice to any other right ,which the undersigned may have against the quotationers in respect of such defects.
12. Replacement under warranty clause shall be made by the the suppliers free of all charges at site including freight ,insurance and incidental charges.
13. Bill should be raised with signed challans(Both in Triplicate) for convenience of payments which shall be made after demonstration and /or installation of the item /as per condition state above
14. Supplier should have to produce a Xerox copy of the trade license duly signed by himself .
15. Supplier should have to produce a Xerox copy of valid GST Registration certificate.
